The Golden Journey Of Gold – One Being Sovereign Gold' (SGB)

Greetings Readers,

You might have heard of many investment options for the financial wellness & Wealth creation, be it Mutual funds, Time - Deposits, Equity Market or Real e-state. Different kinds of investors go with different investment options based on their inclination and perception of Investment bracket. But the conventional & largely accepted of all being investment in 'Gold'.

GOLD!! What comes the first thing in our mind thinking for gold?

A Precious metal being a good investment option, the one which have always been in upswing trend comparing its historical numbers. The Journey of GOLD has always been the one with golden feathers. Investors have always been fortunate with deployment of their investments in gold.

One such form of Gold investment is investment in Sovereign Gold Bond (SGB). SGB abbreviation of SOVERIEGN GOLD BOND refers to security in a form of 'BOND' denominating investment in grams of gold. A SGB is a good investment substitute of holding the gold in physical form. It is held in the dematerialized form in Demat A/c's and can also be held in the form of Physical Bond Certificate.

This takes away the cons of storing the physical gold in lockers & Safe. Also, the risk of Duplicate gold or Compromised quality of gold can be overcome. This Bonds can be subscribed in denomination of 1 gram of gold and its multiples (X grams) thereof. This way investment in SGB reflects corresponding Quantity (grams) of Gold investment.

The Sovereign gold bond is a BOND format of gold issued by the Sovereign (a Supreme ruler/a King or Queen) of nation i.e. Government. The SGB is issued by Reserve Bank of India (RBI) on behalf of Government of India (GOI).

Can I also invest in Sovereign Gold Bond (SGB)?

- Any Individuals,
- HUF's,
- Trusts,
- Universities & Charitable Institutions

Defined under the FEMA Act, 1999 are eligible to invest in SGB.

What is the issue price/Payment mode of SGB?

The issue Price is the nominal Value of Gold Bond decided on the basis of Simple average of (Closing Price of gold of 999 Purity) of the last 3 business days of the week preceding the subscription period, which is published by the Indian Bullion and Jewelers Association limited. The issue price can be paid in cash (Maximum of Rs. 20,000), demand draft, Cheque as well as through electronic mode (online mode). With Online mode discount of Rs 50/Gram is given on Nominal Value, compared to When Purchased through Cash.

What is the lock-in Period for my investment in SGB?

The Sovereign Gold Bonds are issued for the tenure of 8 years with an early Encashment/redemption option after 5 Years from the date of issue on Interest Payment dates. However, the investor also has the Option to trade the SGB in the Open Market through Security exchanges before maturity of the SGB, where indexation benefits are also available to long term capital gains arising to any person on transfer of bond.

Can I Subscribe for any Quantity of SGB?

Well, there's prescribed limit on the Quantity (grams) of Sovereign Gold Bonds that can be subscribed by the Different Class of Investors.

Category of Investor- Limit to Subscribe (in Grams)

Ø Individuals- 4 Kgs

Ø HUF's- 4 Kgs

Ø Trusts & Similar Entities- 20 Kgs

The above ceiling has been fixed on a fiscal year basis (i.e. April-March), which means this limit is for a one Financial year. The SGB's can also be Jointly Held and in case of Joint Holding, the investment limit of 4 Kgs will be applied to the first applicant only.

So we might think that the only difference between investment in Sovereign gold bond (SGB) over investment in physical gold is the difference of Storing of physical gold altered with demat form and the discount of Rs. 50/Gram on Online Payment for Purchase of SGB.

Sovereign Gold Bonds

SGB



Well, there's much more than that.

- The SGB Provides financial reward in the form of fixed interest rate @ 2.5% P.a. Where interest is credited semi – annually (Another Compounding benefit) in Comparison with the investment in Physical gold, where no Interest income can be earned.
- The SGB can also be offered as a collateral security for loans from Banks, NBFC's and Financial Institutions. Just like Offering/Pledging the physical Gold as a security collateral for Loan/Gold Loan.
- Not just that, another add on benefit being the Capital Gain on redemption of SGB on maturity. That is Capital Gains Tax arising on redemption of SGB to an Individual is EXEMPT, which makes it much attractive for the long term investors.

On maturity, bonds are redeemed at the prevailing market rate along with the due interest, this way benefits of SGB truly seems like a gold treasure ensuring recurring interest earnings as well as Tax Exemption on maturity proceedings. Therefore, it is rightly a good investment switch to the physical gold with comparatively lesser risk exposure at good yield to investors.

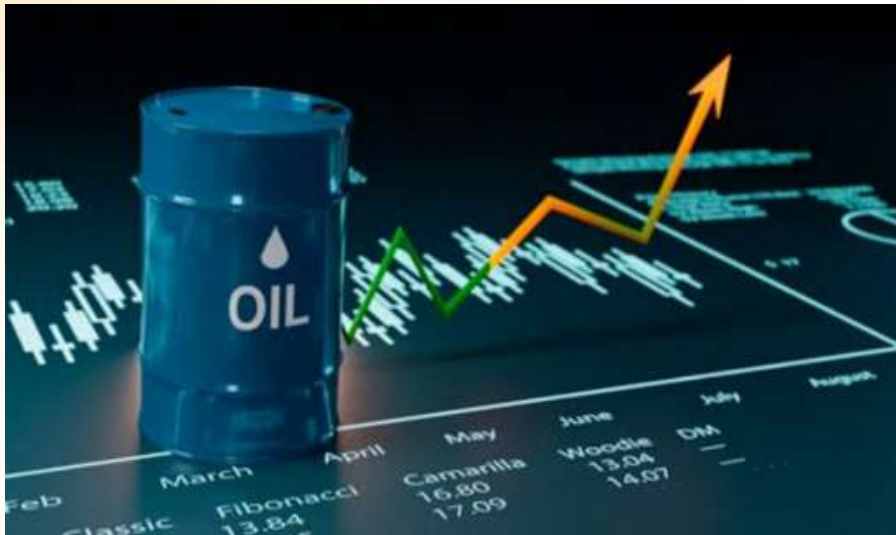

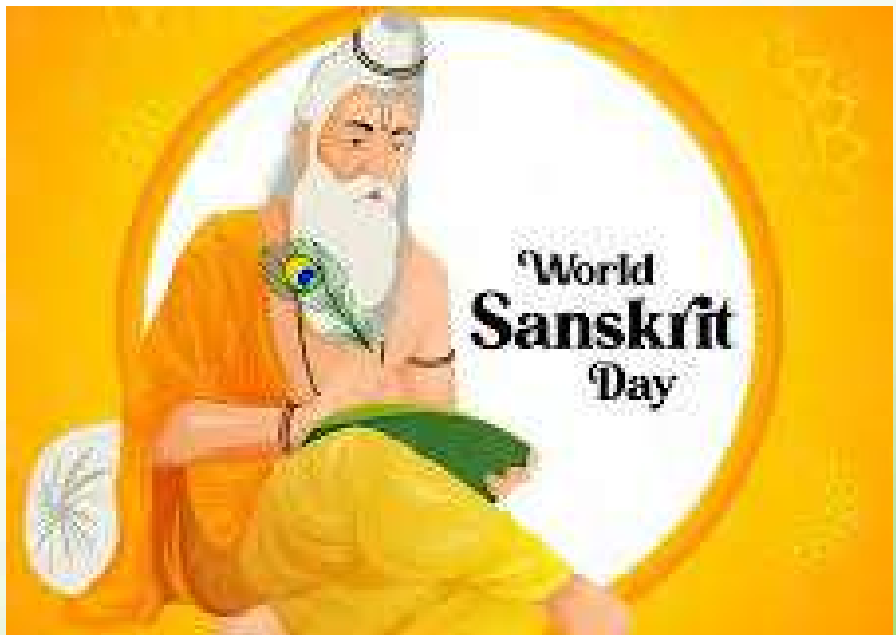

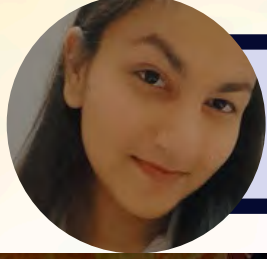
