Overview of Section 194-BA

#### Applicability:

· Deduction of TDS by any person responsible for paying any person any income by way of winning from any online game.

#### Conditions:

- · Deductor Resident / Non-Resident
- · Winner of Online Game Resident / Non-Resident

#### Rate of TDS:

- · 30% at the time of withdrawal of "Net winning" amount and
- · 30% on the remaining amount in the user account at the end of the Financial Year (Not withdrawn during the F.Y.)

Threshold Limit: -No threshold limit.

Effective date: - April 1, 2023

Time of Deduction: At the time of withdrawal from the user account.

(On the amount not withdrawn from the user account, TDS will be deducted at the end of the Financial Year). Definitions:

- 1. "Online Game" means a game that is offered on the internet and is accessible by a user through a computer resource including any telecommunication devices is termed as online game.
- 2. "User Account" means account of a user registered with an online gaming intermediary.
- 3. "Online Gaming intermediary" means an intermediary that offers one or more online games. Example: Dream11, Rummy circle, My 11 Circle, Pokerbazi.
- 4. "Non-taxable deposit" means the amount deposited by the user in his user account which is not taxable.
- 5. "Taxable deposit" means any amount deposited in the user account which is not a nontaxable deposit and includes any amount paid directly to the user not through the user account e.g. joining bonus, referral bonus.

1. "Withdrawal" means any amount withdrawn by the user from any user account.

How to calculate "Net Winning"?

As per CBDT Notification No. 28/2023

Case:1

Net winnings calculation - basic formula: -

Net winnings =

A = Total amount withdrawn

+

D= Closing balance as on 31.03.20XX

**LESS** 

B = Total amount of non-taxable deposit made

+

C = Opening balance as on 01.04.20XX

(For the first year, opening balance will be zero)

Note: If the calculation of the formula of Net Winnings results in negative amount, then consider it as Zero

#### Case:2

Net winnings calculation -at time of first withdrawal: -

Net winnings =

A = Total amount withdrawn

**LESS** 

B = Total amount of non-taxable deposit made

#### Case:3

Net winnings calculation at the time of subsequent withdrawal: -

Net winnings =

A = Total amount withdrawn

B = Total amount of non-taxable deposit made

E= Total amount of withdrawal during F.Y. on which TDS u/s 194BA is already deducted



# ANGWER OF FEB-25 RIDDLE

#### **Step-by-Step Solution:**

- 1. Calculate Projected Revenue:
  - Current Revenue: ₹50,00,000
  - Additional Revenue from New Product Line: ₹10,00,000
  - Total Projected Revenue: ₹50,00,000 + ₹10,00,000 = ₹60,00,000
- 2. Calculate Projected COGS:
  - Current COGS: ₹20,00,000
  - COGS Percentage of Current Revenue: (₹20,00,000 / ₹50,00,000) × 100 = 40%
  - Projected COGS: 40% of ₹60,00,000 = ₹24,00,000
- 3. Calculate Projected Operating Expenses:
  - Current Operating Expenses: ₹15,00,000
  - Increase due to Inflation: 10% of ₹15,00,000 = ₹1,50,000
  - Additional Marketing Budget: ₹3,00,000
  - Additional Salary Expense: ₹4,00,000
  - Total Projected Operating Expenses: ₹15,00,000 + ₹1,50,000 + ₹3,00,000 +
     ₹4,00,000 = ₹23,50,000
- 4. Calculate Depreciation on New Equipment:
  - Cost of New Equipment: ₹5,00,000
  - Depreciation over 5 years: ₹5,00,000 / 5 = ₹1,00,000 per year
- 5. Calculate Projected Net Profit:
  - o Total Projected Revenue: ₹60,00,000
  - Total Projected COGS: ₹24,00,000
  - Total Projected Operating Expenses (including depreciation): ₹23,50,000 +
     ₹1,00,000 = ₹24,50,000
  - o Projected Net Profit: ₹60,00,000 ₹24,00,000 ₹24,50,000 = ₹11,50,000

#### **Recommendations:**

- Review Marketing Strategies: Ensure that the additional marketing budget is spent effectively to maximize the return on investment.
- Cost Control: Monitor operating expenses closely and look for opportunities to reduce costs without compromising quality.
- Cash Flow Management: Maintain a healthy cash flow by planning for the new equipment purchase and additional salary expenses in advance.
- Diversify Revenue Streams: Explore other potential revenue streams to further enhance profitability and reduce dependency on the new product line.
